Recently, through the support and actions of our Maine Senators, at this moment we have a short reprieve from the attack on health care for all. However, we are still experiencing a significant dismantling of vital public health programs. This is happening on both a federal and state level, as many changes are leading to shifts in funding and the restructuring of public health programs and resources. As proponents of public health in the State of Maine, we have an obligation to raise awareness about public health, what we do, and the communities we serve. As a rural state facing numerous issues with a growing substance abuse epidemic, health care and oral health access, and an isolated aging population, it is necessary for programs to reach these areas of need through outreach at the local level.

Therefore, we stand with organizations like the Maine Public Health Association, American Public Health Association, the National Network of Public Health Institutes, and many others who work to spearhead important public health issues nationally and in Maine. Despite ongoing challenges, it is crucial to not lose sight of the valuable work that has been done and the work that is being planned and implemented across many communities.

The MCD Public Health Team has received some good news over the past few weeks:

- We received official notification from HRSA, and from the Offices of Senators Collins and King that our proposal was funded to continue to serve as the Northeast Telehealth Resource Center, covering all of New England, New York and New Jersey. This extends our efforts through August 2020, and we look forward to seeing how the telehealth space continues to evolve in that time!
- The TDES© Program (Telephonic Diabetes Education and Support) has successfully renewed its contract with the Maine Municipal Employees Health Trust. Our TDES team has built a long-standing relationship with the MMEHT over the last decade, and the program continues to have a growing impact on the health and well-being of their members and more recently retirees, who work and live all over the state of Maine.
- The <u>WellStarME</u> team also recently renewed and just began work on year two of their three
 year contract with the State of Maine to coordinate a broad spectrum of services and
 resources to improve the health and well-being of more than 32,000 employees and
 dependents state-wide.
- We also recently learned that our abstract: "How a Statewide Rural Active Living Assessment will be used to Impact Maine's Health" has been accepted for presentation at the MPHA Annual Conference in October. We hope you'll join colleagues Amanda Jordan (MCC Environmental Steward), Dawn Littlefield (Healthy Weight Coordinator) and Doug Beck (Outdoor Recreation Supervisor), as they present the culmination of their work and vision for utilizing this data to enhance state-wide recreational opportunities!

Public Health Update at the State Level

Did you know that August is National Immunization Awareness Month? Vaccination is important because it protects the person receiving the vaccine and helps prevent the spread of disease, especially to those who are most vulnerable to serious complications (such as infants and young children, the elderly, and those with chronic conditions and weakened immune systems). The National Public Health Information Coalition has created a toolkit to promote the importance of immunizations during National Immunization Awareness Month. We encourage you to use the valuable resources in this toolkit throughout the year.

Here in Maine, the Maine Immunization Program works to spread information and resources out to health care providers across the state. Quality Assurance Specialists **As hley Lauze** and **Susan Greene** travel across Maine conducting Vaccines For Children Compliance site visits and AFIX (Assessment, Feedback, Incentives and eXchange) visits. Vaccines For Children is a federal entitlement program that funds states to ensure all children and adolescents are fully vaccinated as recommended by the Advisory Committee on Immunization Practices (ACIP). Compliance site visits ensure vaccines are being stored and administered properly, wastage is minimized and federal dollars are maximized. AFIX visits focus on provider education and improving immunization rates within the practice. Providers also have access to a team of educators, Vaccine Management specialists, and ImmPact database specialists to ensure their patients are fully

vaccinated.


